Introduction

His experience and expertise spans sectors, including construction, infrastructure, energy, financial services, and FMCG.

Hiroo's role extends beyond counsel to arbitrator, having presided over significant arbitrations, including recent appointments as Presiding Arbitrator under SIAC and Co-Arbitrator under LCIA. His election to the Court of the Dubai International Arbitration Centre in 2023 underscores his standing as a key figure in the global arbitration landscape.

- Representing Cox & Kings in arbitration proceedings against SAP India Pvt. Ltd. and SAP GmbH, addressing the inclusion of nonsignatories in arbitration under Indian law. This case culminated in a landmark Supreme Court judgment that upheld the "Group of Companies Doctrine."
- Representing Aquatech Systems Asia Pvt. Ltd. in an arbitration against SKS Power Generation (Chhattisgarh) Ltd. concerning a water purification plant. The tribunal delivered a favourable award, which is currently under challenge in the Delhi High Court, with parallel proceedings ongoing before the NCLT.
