Introduction

Her experience includes precedent-setting matters such as the NN Global curative petition before a 7-Judge Bench of the Supreme Court and a landmark Delhi High Court ruling on re-agitation of arbitral claims and partial enforcement of awards.

Beyond disputes, Hiral advises clients at the negotiation stage on contract risks, termination consequences, and settlement strategies. Her earlier work also spans criminal and white-collar prosecutions, including the 2G Spectrum and Coal Block Allocation matters, along with other high-profile corruption and disproportionate assets cases.
